At Shiseido's Board of Directors Meeting, Mr. Shinzo Maeda has been unofficially reappointed as President & CEO based on the guidance of the Nomination Advisory Committee chaired by an external auditor. Shiseido stipulates the limit of the term of service of corporate officers under the same title and position to be "four years, in principle, along with an extension of two years" as per internal regulations of executive officers. The term of service of Mr. Maeda as President & CEO will be four years as of the Ordinary General Meeting of Shareholders scheduled to be held at the end of June 2009; based on the relevant internal regulations, however, the term of service would be extended in accordance with the resolution made at the Board of Directors Meeting.

Additionally, Corporate Executive Officer Masaaki Komatsu will be promoted to Corporate Senior Executive Officer as of April 1, 2009. Furthermore, decisions regarding changes of Corporate Officers who do not hold the concurrent post of Director as well as the duties of Corporate Officers after April 1 will be disclosed at a later date.
