# Shiseido Co., Ltd. to Make Administrative Changes and Transfer Personnel

Effective April 1, 2011, Shiseido Co., Ltd. will implement certain administrative changes and transfer designated personnel as follows.

#### 1. Administrative Changes

- (1) The Digital Business Development Department will be newly established under the Domestic Cosmetics Business Division with the aim of expanding points of contact with new consumers.
- (2) The SBU (Strategic Brand Unit) Administration Department, which is under the umbrella of the Domestic Cosmetics Business Division, will change its name to the SBU Business Administration Department.
- (3) The Professional Global Marketing Department will be newly established under the Professional Business Operations Division with the aim of strengthening brand marketing in Asian markets centered on China, which is expected to realize expanded growth in the future.

- (4) The Consumer Information Center will be newly established as a department of the Head Office by transferring the functions of Shiseido Business Solutions Co., Ltd. (hereinafter, "SBS") and the Consumer Information Center.
- (5) The Regulatory Affairs Department will be newly established, thereby transferring the pre-launch evaluation functions of quasi-drugs and cosmetics and management functions of quality-related seminars, which are handled by the SBS's Technical Support Department, as well as pharmaceuticals-related functions (pharmaceutical affairs, indication and trademark-related functions).
- (6) The Beauty Solution Development Center will change its name to the Beauty Creation Research Center.
