1. Reasons of appointment

- Dr. Eiko Tsujiyama currently serves as a professor and Dean of the Graduate School of Commerce of Waseda University. As a Certified Public Accountant with extensive knowledge in finance, accounting and taxation, and experience in implementing various public services
- such as a Professional Member of the Tax Commission, Cabinet Office, Government of Japan, Dr. Tsujiyama is expected to be fully capable in fulfilling her role as an auditor.
- Dr. Tsujiyama currently serves as an external corporate director and an external auditor for several companies and has vast experience and knowledge in corporate management.
- Amid accelerating the globalization of Shiseido management, Dr. Tsujiyama is expected to advise and propose various aspects related to management in promoting Group consolidated management, including growth strategies, fund procurement, finance, accounting and overseas subsidiaries.
- Dr. Tsujiyama will bring value to management from a female perspective and is expected to contribute to reforms from a customer standpoint.
