# Shiseido Co., Ltd. to Make Administrative Changes and Transfer Personnel

Effective April 1, 2014, Shiseido Co., Ltd. will implement certain administrative changes and transfer designated personnel as follows.

#### **1. Administrative Changes**

- (1) In order to create synergies through consolidating the operations of our two websites, "Beauty & Co." and "watashi+", that were introduced in 2012, the Digital Business Development Department and the Web Business Department, which are respectively responsible for promoting these two websites, will be integrated and the Digital Business Planning Department will be newly established. Accordingly, the Web Business Department and the Digital Business Development Department will be dissolved.
- (2) As a means of responding to diversifying media more strategically, the communication functions of the Communication Strategy Group in the Cosmetics Business Planning Department, Domestic Cosmetics Business Division and the Communication Planning Group in the Advertising Creation Department will be consolidated and the Strategic Communication Department will be newly established.
- (3) In order to further realize high quality advertising production, the organization will be restructured and the Advertising Creation Department will change its name to the Advertising and Design Department.
- (4) In order to strengthen responses for Asian markets in the Professional Business Operations Division, some of the functions handled by the Professional Global Marketing Department will be transferred to the Professional Business Planning Department with the aim of realizing a promotion system in which marketing, sales promotion and business management are carried out seamlessly.
