Notice of Administrative Changes and Transfer of Personnel

Shiseido Company, Limited hereby announces that it will implement partial organizational reforms and personnel transfers as detailed below effective July 1, 2016.

- 1. Partial organizational reforms in Shiseido Japan Company, Limited
 - With an aim of realizing joint integrated marketing with brands as pivots, sales organization reforms were conducted in the Chubu and Kinki areas in January 2016, and will be expanded to other areas. Specifically, Shiseido Japan will reform the current sales units into Sales Departments in Cosmetics Specialty Store Division in charge of specialty stores, and in Cosmetics Brands Division that takes care of retail companies.
 - Specialty Store business will be restructured and divided into 5 branches, namely Hokkaido Sales Branch, Tohoku Sales Branch, Kanetsu Sales Branch, Chu-Shikoku Sales Branch, and Kyushu Sales Branch that combines Kyushu and Okinawa Branches. In addition, Shiodome Sales Branch will be newly established to support retail sales over the telephone.
 - Cosmetics Brands Division will be comprised of Nishi-Nippon Sales Department that combines Hokkaido and Tohoku Departments, Kanto · Koshinetsu Sales Department, Chu-Shikoku Sales Department and Kyushu · Okinawa Sales Department.
 - With the reform of Sales Department and Planning Department in Cosmetics Specialty Store Division, the current Planning Department will be focusing on business management and business planning under the new name of Business Administration Department.
 - In order to enhance sales capabilities and communication of FT Shiseido Company, Limited the current Sales 1 and Sales 2 Departments will be integrated into Personal Care Sales Department and Higashi-Nippon Sales Department, and Nishi-Nippon Sales Department will be newly established.
