## Notice of Administrative Changes and Transfer of Personnel

Shiseido Company, Limited hereby announces that it will implement partial organizational reforms and personnel transfers as detailed below effective January 1, 2017.

1. Partial Organizational Reforms

- Set up a new function called "Innovation Design Lab." that creates and promptly implements innovations and directly reports to the CEO.
- Transform Skincare COE (Center of Excellence) Group of Business Strategy Department, Global Prestige Brands Division, into a separate department, called "Skincare COE Department", in order to clarify the position of Skincare COE as a hub in the skincare category of Shiseido Group.
- Disband Asia Pacific RHQ Corporate Planning Department, in charge of marketing and corporate planning in the Shiseido Asia Pacific Headquarters, and transfer those functions to Shiseido Asia Pacific Pte. Ltd. to accelerate decision making as well as strengthen customer management and marketing in the Shiseido Asia Pacific Headquarters.
- Transfer proxy functions of the overseas brand holder in Global Cosmetics and Personal Care Brands Division to Shiseido Japan Company, Limited and FT Shiseido Company, Limited in order to eliminate duplication in functions across brand holders and proxy bodies in terms of brand business management of Asia Pacific, China and Japan regions. In addition, disband Global Cosmetics and Personal Care Brands Division and transfer the marketing function of Za to the Chinese subsidiary, Shiseido China Company, Limited, and China Business



Innovation Project Office.

• Convert Investor Relations Department of Corporate Communications Division into a separate department under the direct supervision of CFO, to further strengthen ties with financial domain.
