Nomination of Shinsaku Iwahara for the Candidate for New External Director

1. Reason for Nomination

- The Company deems external directors to be one of the cores of corporate governance, and expects that these directors will fulfill the function of monitoring its business operations from a standpoint that is independent of the Company, thereby playing an important role for the maximization of corporate and shareholder value. Based on this recognition, the Company believes that it is important for external directors to demonstrate great ability from diverse viewpoints as members of the Board of Directors, capitalizing on their abundant experience.
- Mr. Iwahara is a university professor and researcher specializing in law, mainly with regard to companies and financial systems, with deep expertise in the field. He also has played important roles at the Legislative Council and Financial System Council, and has been involved in the establishment of the supervisory and examination systems of authorities such as the Financial Services Agency. He thus possesses abundant experience. By appointing Mr. Iwahara, who is an expert in corporate governance, as an external director, the effectiveness of the Company's Board of Directors will further increase. Mr. Iwahara has therefore been selected as a candidate for an external director.
- Based on the Company's Criteria for Independence of External Directors and Audit & Supervisory
 Board Members, the relationships between the organizations that Mr. Iwahara serves and the
 Shiseido Group were surveyed, and it was confirmed that Mr. Iwahara can maintain high level of
 independence from the Shiseido Group.
