Shiseido Co., Ltd. to Make Administrative Changes and Transfer Personnel

Effective October 1, 2008, Shiseido Co., Ltd. will implement certain administrative changes and transfer designated personnel as follows.

Effective October 1, 2008, Shiseido Co., Ltd. will:

1. Implement Administrative Changes

Along with the commencement of business by Shiseido Business Solutions Co., Ltd.*, we will reorganize the functions of the Head Office corporate administration departments and change the names of these departments as follows.

* Shiseido Business Solutions Co., Ltd., established in July 2008 as a subsidiary (wholly owned by Shiseido) to handle the Shiseido Group's business administration functions, will commence full-scale operations in October.

(1) Reorganize Functions and Change the Name of the Financial Department

The current Financial Department will specialize in investor relations (IR), stock administration and shareholder correspondence, and the department's name will be changed to the Investor Relations Department. At the same time, its financial strategy functions will be transferred to the Corporate Planning Department and business affairs related to finance, accounting and taxation will be transferred to Shiseido Business Solutions Co., Ltd.

(2) Reorganize Functions and Change the Name of the Technical Department

The current Technical Department will specialize in the overall coordination of safety management and pharmaceutical affairs as well as the handling of quality assurance, and the department's name will be changed to the Quality Management Department. At the same time, its business affairs related to quality control, quality assurance, and pharmaceutical affairs along with Asia regulatory research and analysis will be transferred to Shiseido Business Solutions Co., Ltd., while overseas technology strategy functions will be transferred to the Technical & Production Planning Department.

(3) Reorganize Functions and Change the Name of the Consumer Information Center

The current Consumer Information Center will specialize in overall coordination of
customer information, strategies for responding to global customers and Web planning
promotion, and the department's name will be changed to the Consumer Relations
Department. At the same time, its customer contact, customer response support, customer
information systems operation management and beauty seminar operations will be
transferred to Shiseido Business Solutions Co., Ltd.
